Weighting The sample was weighted based on gender, age, race, and educa-

tion, based on the American Community Survey, conducted by the U.S. Bureau of the Census, as well as 2020 Presidential vote (or non vote), and voter registration status. The weights range from 0.337 to

3.304, with a mean of 1 and a standard deviation of 0.45.
