- 1) <u>Eligibility</u>: The YouGov [YouGov Chat] Sweepstakes (the "Sweepstakes") is open to natural persons who (i) are legal residents of the 50 states of the United States and the District of Columbia (D.C.); (ii) between the ages of 13 and 17 years old as of the date of entry; (iii) who receive an ad/invitation served through the Facebook group of companies, Snapchat and/or TikTok; and (iv) who click on the ad, answer a question, answer chat questions and complete all questions of a survey provided by YouGov.Chat, YouGov America Inc. incorporated in Delaware, with registered office at 999 Main Street, Suite 101, Redwood City, California, USA ("Sponsor"). Each person must complete an initial question, chat questions and a survey, which will be 38-58 questions, during the Entry Period to receive the opportunity to enter. This is a range because some of your answers might be linked to additional questions about the same topic. All of these questions are questions presented by Sponsor. The questions concern your attitudes to life, media habits and general interest. You also will be asked to provide your name and email address for communications about the Sweepstakes and Sponsor's goods and services, and to confirm you have permission from your parent or guardian to enter ("Parent Consent"). Entries (including responses to all questions) are the property of Sponsor and will not be returned. Upon accepting these Official Rules and indicating consent to enter the Sweepstakes, these persons will be entered into the Sweepstakes ("Entrants"). Limit one (1) entry per person.
